



### Breakdown of Total LCFF Funds





These charts show the total general purpose revenue Stella Middle Charter Academy expects to receive in the coming year from all sources.

The total revenue projected for Stella Middle Charter Academy is \$9,103,566, of which \$6,477,180 is Local Control Funding Formula (LCFF), \$2,173,555 is other state funds, \$114,000 is local funds, and \$338,831 is federal funds. Of the \$6,477,180 in LCFF Funds, \$1,822,143 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use funds to serve students.

Per our Charter Authorizer, it is recommended we meet an internal net income reserve each year. We have set that target at 1% of annual expenses.



# Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

There were no substantive differences between planned actions and actual implementation of the actions

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Increased post-pandemic demand for emotional and behavioral support necessitates additional special education staff and investment in outsourced services (social work, counseling, etc.) to ensure individualized attention and student success. The cost of curriculum was captured in instructional materials and software.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The school saw decline in both CAASPP Math and ELA for the percent of students meeting or exceeding the standard. Math CAASPP declined from 31.60% in the baseline year to 15.09% in Year 3, and ELA CAASPP increased from 43.98% to 36.21%. The school attributes this decline to the ineffectiveness of the following actions: General Education Teachers , Curriculum, Instructional Materials, and Software - Academic Achievement. In an effort to improve outcomes for 23-24 the school implemented more structured coaching and administered IABs and FIABs in the CAASPP portal. They began high dosage, small group tutoring from within our own staff and outside partners. The high dosage tutoring was the strongest in 23-24 year than in years past. The school also transitioned to Standards Based Grading system; and trained teachers on standards based assessments and proficiency scales. The school is eagerly awaiting 23-24 scores to determine effectiveness for this school year. The school saw a

significant increase in the percentage of students redesignated from EL to FEP status from the baseline to Year 1 from 10.8% to year 3 55%. The school also saw an decline in Math CAASPP scores for English Learners from 14.81% meeting or exceeding the standard in the baseline year to 0% in Year 3. This is due to the ineffectiveness of the following actions EL Curriculum & Personnel and Interventions for High Needs Students. The school continues to focusing on ways to improve the effectiveness of this action to increase CAASPP ELA scores for English Learners, and other outcomes. The school celebrates the consistent growth of iReady scores for Students with Disabilities who have met the 50% threshold of meeting typical annual growth in iReady this is true for all three years of the LCAP in both Math and Reading except year 2 in Math. While SWD students are demonstrating growth on i Ready they have a demonstrated decline in the % meeting or exceeding state standard on CAASPP from year 1 to year 3 in both ELA and Math. These divergent outcomes indicate that the action Special Education Services and Personnel need to clarify how outcomes are assess to drive decision making.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The school is focusing on changing how the supplemental instructional support action is implemented at the school level. Specifically, the school is focused on training school leadership to effectively coach and provide feedback to teachers, such that our instructors are able to better meet the needs of our high needs students. Additionally, the school is revising how the action Intervention for High Needs Students is executed to ensure that coordination of intervention programs is tailored to student needs and implemented with fidelity. The school is also considering revising aspects of the action curriculum in the next LCAP cycle to ensure that instructional materials and curriculum are culturally relevant and grounded in best practice. Additionally, the school plans to continue with high dosage tutoring and implementing IABs and FIABS. The school's approach to set targets was to increase proficiency year over year. They looked at the current data and trends year over year, compared the numbers to the state and also reviewed what changes would occur in the CA Dashboard color coding system. They aimed to change colors to better levels for each of the years. One change target wise that is being made within the LCAP and across internal school plans is shifting the focus on iReady stretch growth targets in addition to typical growth targets. This is to ensure that students are growing beyond one year's worth of progress to close grade level proficiency gaps in ELA and Math.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Our investment in enrichment programming has grown due to receiving a significant grant from the California Expanded Learning Opportunities Program (ELO-P). This grant specifically targets funding for after-school and summer programs that enhance student learning beyond the core curriculum. Increased investment in additional student and family services personnel to provide our students with a comprehensive support system. This includes personnel such as different counselors, parent liaisons, and support staff who play a crucial role in promoting student well-being, academic success, and family engagement. The increase in spending on student activities reflects our commitment to fostering a well-rounded educational experience. These activities provide students with opportunities to develop their social, emotional, and leadership skills outside the classroom, complementing their in-class learning

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The school sends out Parent and Family Surveys to assess areas of strength and improvement. Our families know we value their opinion which is why 79% of parents returned surveys addressing family efficacy, school fit, school climate, and school safety. We know that our families are confident in their relationships with staff because our Family survey reflects that 97% of parents rate the school positively. One of the school's biggest strengths is the welcoming environment that has been built with families. 85% of families attend at least one school event including, but not limited to: Coffee with the Principal, Conferences, Parent Education Seminars, Back to School Night, and Family Nights. Additionally, 82% of families attended a yearly counselor meeting. Through events that highlight the cultures of students, implementation of Council in Schools, and connection via phone and ParentSquare our staff and families have learned more about each other and the school has increased two-way communication between

families and staff. These outcomes can be attributed to the effectiveness of the following actions; Family Engagement Coordinator, Software - Family Engagement and Supplies and Materials - Family Engagement. Additionally, the school has identified the following areas as strengths of the school's culture: teachers and staff were trained using Restorative Practices and Responsive Classroom, that included foundational culture building and classroom management strategies including Community Circles, Logical Consequences and Community Agreements. These practices have been slowly becoming more effective as the results of students feelings of belonging were 39%, which is an increase from 21-22 when the average was 35%. We attribute these outcomes to the following actions within the LCAP, software - school culture, and student and family services personnel. The organization is in the first year of partnership with Community Schools. As such the school has hired a Community Schools Manager to use the survey results and needs assessment to connect the school to vital community resources for safety and belonging. Current practices being implemented for school safety are showing success. The school reports that 51% of students feel safe according to the Panorama student survey. Teachers and staff were trained using Restorative Practices and Responsive Classroom, that included foundational culture building and classroom management strategies including Community Circles, Logical Consequences and Community Agreements. There is not a wide range when reviewing student safety survey responses by student demographics, which indicates that students regardless of identity marker are feeling similarly safe of campus.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The school will be focusing on using the action Student and Family Services Personnel to support stronger establishment of aligned school behavior systems. The personnel within this action will be coaching teachers on how to increasingly implement restorative justice practices in concrete ways within their classrooms. Feedback we received from staff in the listening sessions in the fall was that restorative practices felt theoretical versus actionable. The action Student and Family Services will be working to build systems and processes with teachers that support restorative practices in a practical way within the classroom. In order to address chronic absenteeism the school will also regularly host attendance meetings, hire an AP to support attendance meetings and host these meetings in-house immediately when students reach a certain number of absences. Additionally, with regards to family engagement we will be using the software - family engagement and family engagement coordinator action to further evolve the way we track and measure family outcomes. In the upcoming year we will review family engagement results by family demographics to ensure that as a school families are having a similar experience. Additionally, the school will be changing the metics % of families who attend a school event from one event to two events.

There were no substantive differences between planned actions and actual implementation of the actions.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

With respect to Operational materials there was an overestimated projections for operational equipment (technology, furniture, fixtures, equipment). There was also an increased investing in both our facilities (contracted repairs & upgrades) and operational staff (deans & support personnel) to ensure a well-maintained and efficient learning environment.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Facilities limitations for the school have presented challenges. Facilities challenges can be seen in the SARC Rating of the school decreasing from 100% in 20-21 to 91% in 22-23. As was stated in the 22-23 LCAP reflection the "Operational Personnel and Services Personnel" actions have been imperative in maintaining safety on campus during this LCAP cycle. The school also identifies difficulties in teacher recruitment due to the teacher shortage, and that because of this, the school has recruited educators from out of state, some of whom experience challenges in transferring their credentials, which has impacted the school's ability to place properly credentialed and assigned teachers. Since the baseline year, the school has maintained 100% of students having access to standard aligned materials, 100% alignment of instructional materials to state standards, 100% of English Learners participate in CCSS and ELD standard aligned instruction, and met the standard for Broad Course of Study. These can be attributed to the effectiveness of the following actions: Operational Materials, Operational Personnel and Services, Software - Operations, Operational Services. ### **General Information**

Since opening our first school in 2003, Bright Star Schools has been building a high-quality transitionalkindergarten (TK) through 12th grade model for our families in each of our three communities. In nine, tuition-free public schools in three communities -- West Adams, Koreatown, and in the San Fernando Valley -- our 3,000+ students experience rigorous academics, inclusive education, social-emotional support, and rich life opportunities beyond the classroom. The students at Stella Middle Charter Academy are predominantly from the west Adams community. While the community is culturally rich the neighborhood does not have access to the breadth of resources many more affluent communities do. Additionally, many of our school's families have recently come to the United States, and in many cases English is not the primary language spoken at home. Approximately, 23% of our students are English learners, 94.88% of our students qualify for free and reduced priced meals, and 16% of our students are students with disabilities. These factors make the school's job of creating an educational program that is centered around the specific needs of the community and filled with experiences and rich educational programming built to ensure student success. At Bright Star Schools, we are guided by our core values and our highest ideals for our students, staff, and schools. The following are Bright Star Schools' Mission, Vision and Core Values. Vision: Bright Star students will become leaders who act with integrity and champion equity to enrich our communities and the world. Mission: At Bright Star Schools, our mission is to provide holistic, inclusive support for all students to achieve academic excellence and grow their unique talents so that they find joy and fulfillment in higher education, career, and life. Core Values: Integridad - means we need to be the best versions of ourselves, to speak our own truth, and to advocate for those whose voices are not heard. Ubuntu - means that our humanity is shared, that we value kindness, and that we support one another to become the people we strive to be. **Reflections: Annual Performance** 

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

On the most recent publicly available CA Dashboard data (22-23) the school had a chronic absenteeism rate of 24.4% which decreased from 26.9% from 21-22. This has resulted in a orange score on the California Dashboard. Similarly, the English Learner progress measure on the CA Dashboard was orange, due to a rate of 48.3.2%, which was a decline of 6.1%. The school was given a yellow on their incidents of suspension, as they had a rate of 1.2% of students suspended at least 1 day which increased .6% from 21-22. The school received a red score in Math with a -99.2 DFS declining by 8.3 points from 21-22. Similarly, the school received an orange score in English Language Arts with a - 39.4 DFS which declined by 11 points. When reviewing student subgroup data the following was observed. Our EL student group had -69 DSF in ELA and -123.5 in Math. Similarly, students who are socio-economically disadvantaged were -39.2 DFS in ELA and -98.9 in Math. Students with Disabilities were -118.2 DFS in ELA and -175.8 in Math. Lastly, the other two significant student groups in 22-23 were first Hispanic and African American/Black students. Hispanic students scored -38.5 DFS in ELA and -94.7 in Math. African American/Black students scored -48 DFS in ELA and -121.4 in Math.

### **Reflections: Technical Assistance**

Once notified of the school's status Bright Star Schools' central office team reached out to Los Angeles County of Education's accountability department to better understand what the ATSI and differentiated assistance statuses meant, the requirements associated and what was needed to exit. The central office then presented this information to the school principal so that the team was all working under the same understanding. The school then began updating its school plan (SPSA) to address the outcomes for students with disabilities given the new ATSI designation. In the process of updating the SPSA plan, the school revisited student outcome data and reviewed where the school budget was either in alignment with resourcing high need areas and/or where it was out of alignment. Once updated the school presented the new school plan to their school site council for review and approval. In spring, 24' the school principal also began meeting with the central network's Chief Business Officer to update with schools 2024-25 budget, one of their areas of focus was to update the budget to more effectively resource for the needs of students with disabilities. In July, 24' the school in partnership with the Bright Star Schools central office will re-examine the school's 2023-24 outcome data, with a specific focus on students with disabilities. Depending on the specific outcomes and the school will then continue re-examine the school budget to address any resource inequities.
