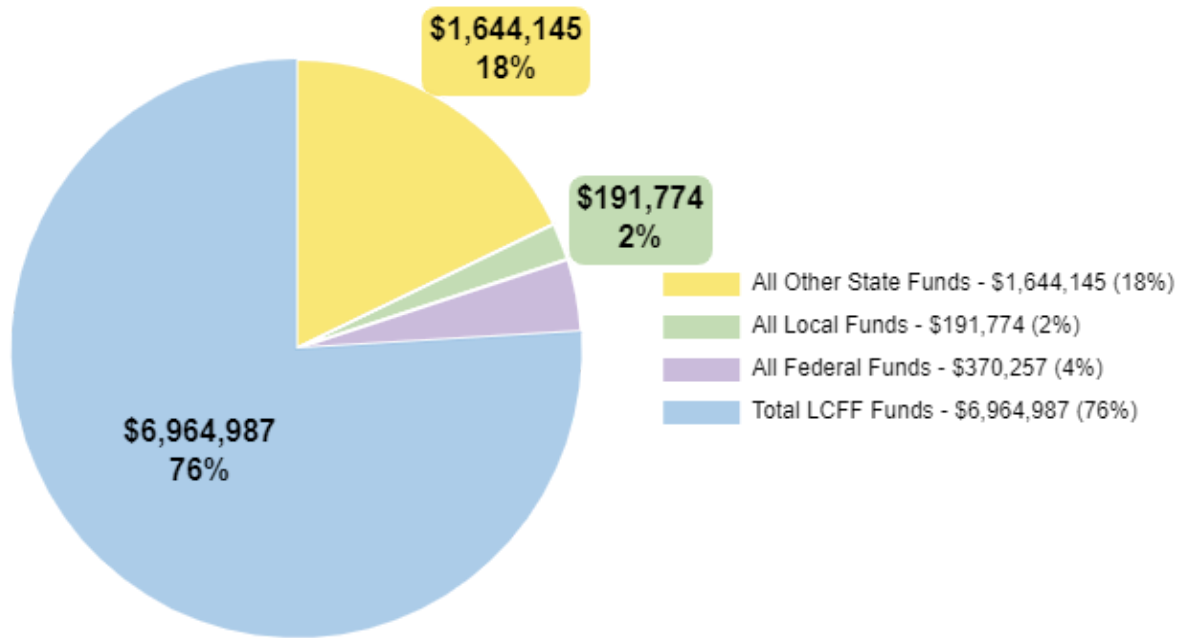

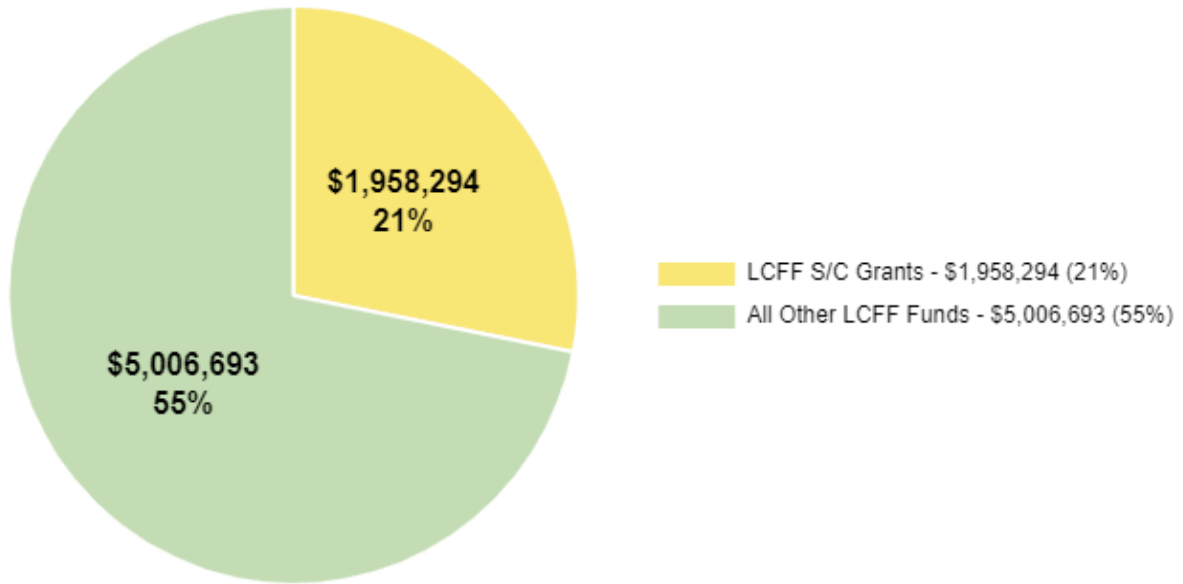

## Breakdown of Total LCFF Funds



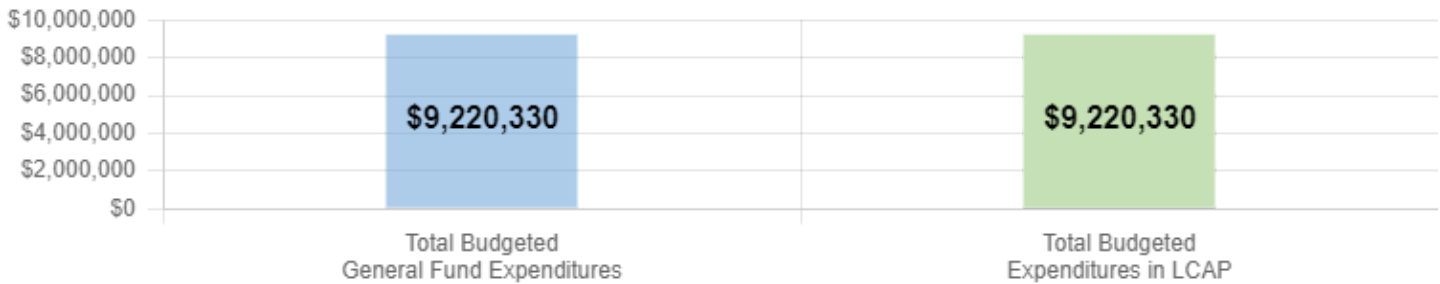

*These charts show the total general purpose revenue Valor Academy Middle expects to receive in the coming year from all sources.*

The total revenue projected for Valor Academy Middle is \$9,171,163, of which \$6,964,987 is Local Control Funding Formula (LCFF), \$1,644,145 is other state funds, \$191,774 is local funds, and \$370,257 is federal funds. Of the \$6,964,987 in LCFF Funds, \$1,958,294 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use funds to serve students.

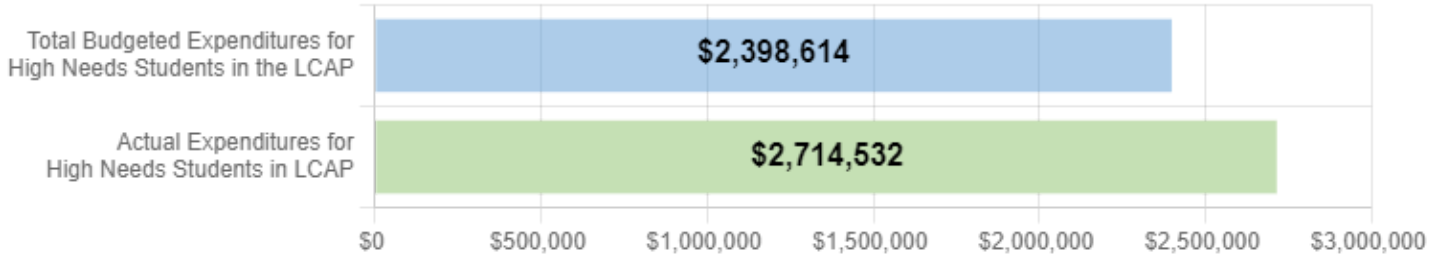

There were no substantive differences between planned actions and actual implementation of the actions

Investment in additional instructional staff. This will allow us to provide essential support for students, maintain lower student-teacher ratios, ultimately leading to a more positive learning environment for all. Increased post-pandemic demand for emotional and behavioral support necessitates additional special education staff and investment in outsourced services (social work, counseling, etc.) to ensure individualized attention and student success. We are investing in additional instructional support personnel, such as instructional assistants, paraprofessionals, and tutors. This expanded team will provide our teachers with valuable support, allowing them to personalize instruction and ensure all students receive the individual attention they need to succeed.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

VAMS The school saw a decrease in Baseline from both CAASPP Math and ELA for the percent of students meeting or exceeding the standard during the pandemic. However, ELA CAASPP increased from 34.31% in Year 1 to 41.26% in Year 2, and Math CAASPP increased from 13.75% to 20.23%. The school attributes this growth to the effectiveness of the following actions: General Education Teachers , Curriculum, Instructional Materials, and Software - Academic Achievement. The school saw a significant increase in the percentage of EL students making progress towards English Proficiency the baseline to



Year 2 from 35.4% to 53.6%. In year 3 the school maintained an increase to 55.5%. This is due to the effectiveness of the following actions EL Curriculum & Personnel and Interventions for High Needs Students. The school continues to improve the effectiveness of this action to increase CAASPP ELA scores for English Learners, and other outcomes. However, the school will continue to focus percentages of Students with Disabilities meeting typical annual growth in iReady. In both Reading Math, the percentage of students with disabilities meeting annual typical growth on the iReady diagnostic was 53% in the baseline year.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The school is focusing on changing how the supplemental instructional support action is implemented at the school level. Specifically, the school is focused on training school leadership to effectively coach and provide feedback to teachers, such that our instructors are able to better meet the needs of our high needs students. Additionally, the school is revising how the action Intervention for High Needs Students is executed to ensure that coordination of intervention programs is tailored to student needs and implemented with fidelity. The school is also considering revising aspects of the action curriculum in the next LCAP cycle to ensure that instructional materials and curriculum are culturally relevant and grounded in best practice. Within the LCAP and across internal school plans the school will focus on iReady stretch growth targets in addition to typical growth targets in order to ensure that students are growing beyond one year's worth of progress to close grade level proficiency gaps in ELA and Math.

## Goal Analysis

A description of any substantive differences in planned actions and actual implementation of these actions.

There were no substantive differences between planned actions and actual implementation of the actions.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Our investment in enrichment programming has grown due to receiving a significant grant from the California Expanded Learning Opportunities Program (ELO-P). This grant specifically targets funding for after-school and summer programs that enhance student learning beyond the core curriculum. Increased investment in additional student and family services personnel to provide our students with a comprehensive support system. This includes personnel such as different counselors, parent liaisons, and support staff who play a crucial role in promoting student well-being, academic success, and family engagement. The increase in spending on student activities reflects our commitment to fostering a well-rounded educational experience. These activities provide students with opportunities to develop their social, emotional, and leadership skills outside the classroom, complementing their in-class learning.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The school sends out Parent and Family Surveys to assess areas of strength and improvement. Our families know we value their opinion which is why 86% of parents returned surveys addressing family efficacy, school fit, school climate, and school safety. We know that our families are confident in their relationships with staff because our Family survey reflects that 94% of parents rate the school positively. One of the school's biggest strengths is the welcoming environment that has been built with families. 98% of families attend at least one school event including, but not limited to: Coffee with the Principal,

Conferences, Parent Education Seminars, Back to School Night, and Family Nights. Additionally, 98% of families attended a yearly counselor meeting. Through events that highlight the cultures of students, implementation of Council in Schools, and connection via phone and ParentSquare our staff and families have learned more about each other and the school has increased two-way communication between families and staff. These outcomes can be attributed to the effectiveness of the following actions; Family Engagement Coordinator, Software - Family Engagement and Supplies and Materials - Family Engagement. Additionally, the school has identified the following areas as strengths of the school's culture: teachers and staff were trained using Restorative Practices and Responsive Classroom, that included foundational culture building and classroom management strategies including Community Circles, Logical Consequences and Community Agreements. These practices have been effective as the results of students feelings of belonging are 39% according to student survey results. We attribute these outcomes to the following actions within the LCAP, software - school culture, and student and family services personnel. The organization is in the first year of partnership with Community Schools. As such the school has hired a Community Schools Manager to use the survey results and needs assessment to connect the school to vital community resources for safety and belonging. Current practices being implemented for school safety are showing success. The school reports that 61% of students feel safe according to their XSELweb or Panorama student survey. Teachers and staff were trained using Restorative Practices and Responsive Classroom, that included foundational culture building and classroom management strategies including Community Circles, Logical Consequences and Community Agreements.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

The school will be focusing on using the action Student and Family Services Personnel to support stronger establishment of aligned school behavior systems. The personnel within this action will be coaching teachers on how to increasingly implement restorative justice practices in concrete ways within their classrooms. Feedback we received from staff in the listening sessions in the fall was that restorative practices felt theoretical versus actionable. The action Student and Family Services will be working to build systems and processes with teachers that support restorative practices in a practical way within the classroom. Additionally, with regards to family engagement we will be using the software - family engagement and family engagement coordinator action to further evolve the way we track and measure family outcomes. In the upcoming year we will review family engagement results by family demographics to ensure that as a school families are having a similar experience. Additionally, the school will be changing the metrics % of families who attend a school event from one event to two events.

We saw growth in our facilities reviews as can be seen in the SARC Rating of the school increasing from 87.5% in 19-20 to 100% in 21-22. The score decreased slightly to 97% in 22-23. As was stated in the 22-



23 LCAP reflection the “Operational Personnel and Services Personnel” actions have been imperative in maintaining safety on campus during this LCAP cycle. The school also identifies difficulties in teacher recruitment due to the teacher shortage, and that because of this, the school has recruited educators from out of state, some of whom experience challenges in transferring their credentials, which has impacted the school’s ability to place properly credentialed and assigned teachers. Since the baseline year, the school has maintained 100% of students having access to standard aligned materials, 100% alignment of instructional materials to state standards, 100% of English Learners participate in CCSS and ELD standard aligned instruction, and met the standard for Broad Course of Study. These can be attributed to the effectiveness of the following actions: Operational Materials, Operational Personnel and Services, Software - Operations, Operational Services. These actions allow our operations team to ensure the school provides adequate materials to our students.

## General Information

Since opening our first school in 2003, Bright Star Schools has been building a high-quality transitional-kindergarten (TK) through 12th grade model for our families in each of our three communities. In nine, tuition-free public schools in three communities -- West Adams, Koreatown, and in the San Fernando Valley -- our 3,000+ students experience rigorous academics, inclusive education, social-emotional support, and rich life opportunities beyond the classroom. The students at Valor Academy Middle School are predominantly from the San Fernando Valley community. While the community is culturally rich the neighborhood does not have access to the breadth of resources many more affluent communities do. Additionally, many of our school's families have recently come to the United States, and in many cases English is not the primary language spoken at home. Approximately, 22% of our students are English learners, 94% of our students qualify for free and reduced priced meals, and 14% of our students are students with disabilities. These factors make the school's job of creating an educational program that is centered around the specific needs of the community and filled with experiences and rich educational programming built to ensure student success. At Bright Star Schools, we are guided by our core values and our highest ideals for our students, staff, and schools. The following are Bright Star Schools' Mission, Vision and Core Values. Vision: Bright Star students will become leaders who act with integrity and champion equity to enrich our communities and the world. Mission: At Bright Star Schools, our mission is to provide holistic, inclusive support for all students to achieve academic excellence and grow their unique talents so that they find joy and fulfillment in higher education, career, and life. Core Values: Integridad - means we need to be the best versions of ourselves, to speak our own truth, and to advocate for those whose voices are not heard. ## Reflections: Annual Performance

On the most recent publicly available CA Dashboard data (22-23) the school had a chronic absenteeism rate of 14.5% which decreased from 20.5% from 21-22. This has resulted in a yellow score on the California Dashboard. We are very proud that the English Learner progress measure on the CA Dashboard was green, due to a rate of 55.5% making progress, which was maintained by 1.9%. The school was given a green on their incidents of suspension, as they had a rate of 2.3% of students suspended at least 1 day which increased 3.6% from 21-22. The school received an orange score in Math with a -89.3 DFS declining by 12.9 points from 21-22. Similarly, the school received an orange score in English Language Arts with a - 29.6 DFS which declined by 8.2 points. When reviewing student subgroup data the following was observed. Our EL student group had -77.3 DSF in ELA and -131.4 in Math. Similarly, students who are socio-economically disadvantaged were -30.8 DFS in ELA and -90.9 in Math. Students with Disabilities were -98 DFS in ELA and -152 in Math. Lastly, the other two significant student groups in 22-23 were first Hispanic and Filipino students. Hispanic students scored -35.2 DFS in ELA and -92.8 in Math. Filipino students scored +63.2 DFS in ELA and -2.7 in Math.
