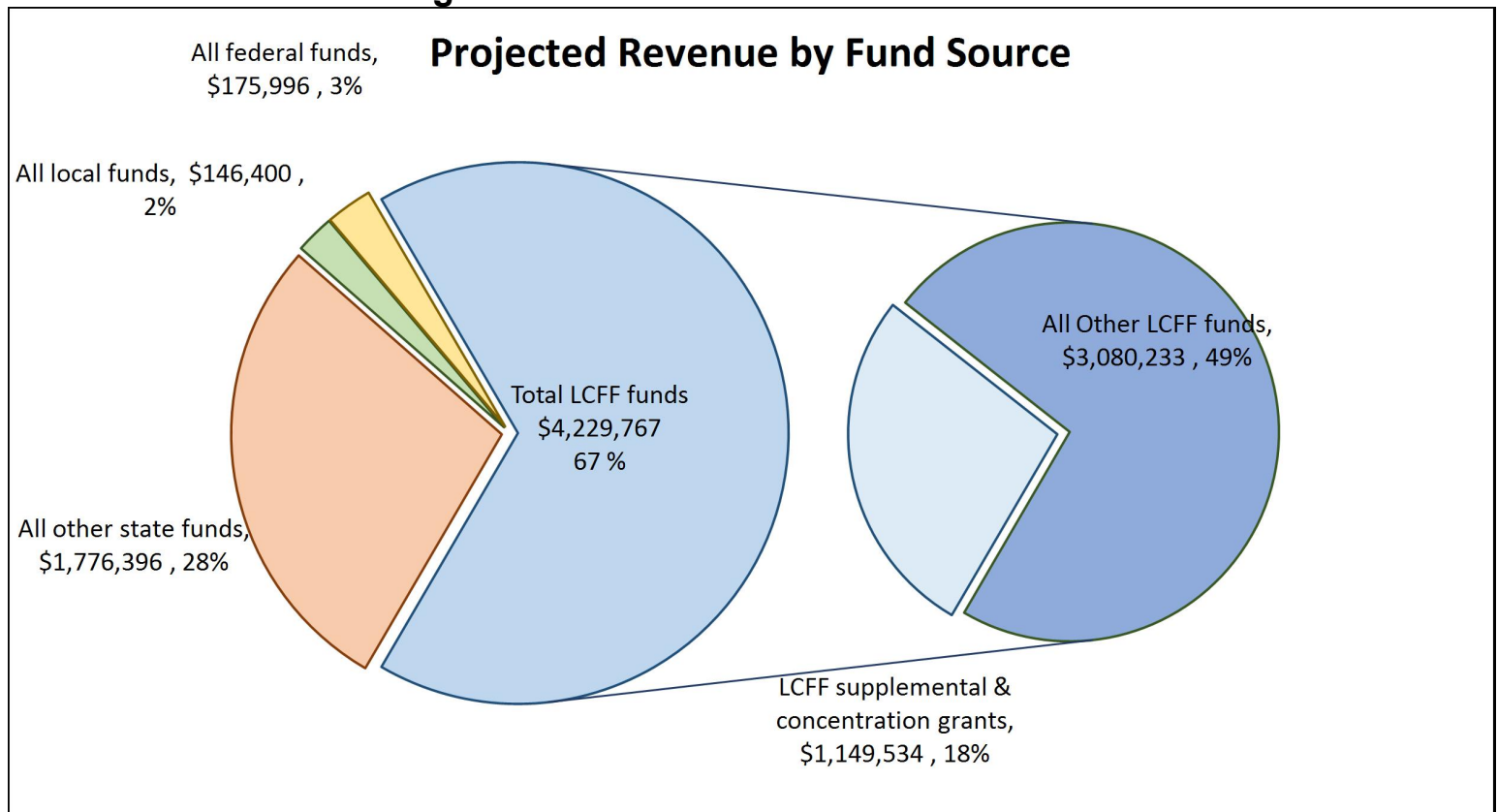

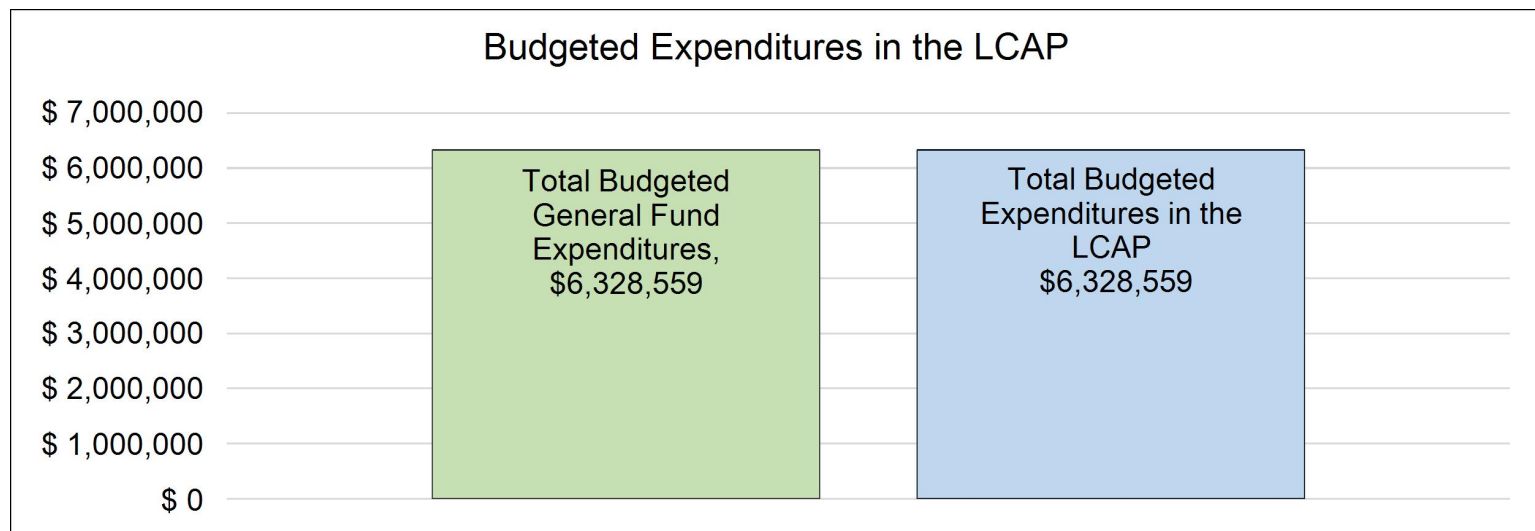


This chart shows the total general purpose revenue Stella Elementary Charter Academy expects to receive in the coming year from all sources.

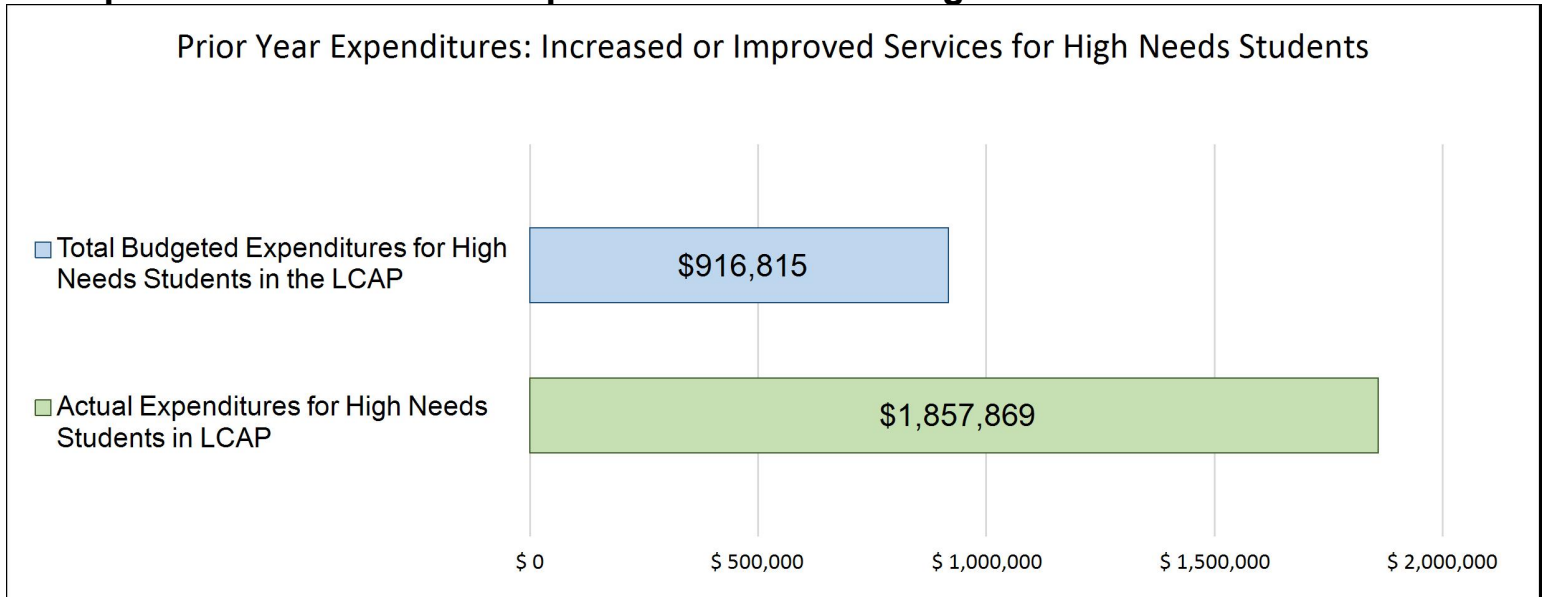

Plan Summary [2026-27]

General Information

Since opening our first school in 2003, Bright Star Schools has been building a high-quality transitional-kindergarten (TK) through 12th grade model for our families in each of our three communities. In nine, tuition-free public schools in three communities -- West Adams, Koreatown, and in the San Fernando Valley -- our 3,000+ students experience rigorous academics, inclusive education, social-emotional support, and rich life opportunities beyond the classroom.

The students at Stella Elementary Charter Academy are predominantly from the South Los Angeles community, specifically near West Adams and Baldwin Hills. While the community is culturally rich the neighborhood does not have access to the breadth of resources many more affluent communities do. Additionally, many of our school's families have recently come to the United States, and in many cases English is not the primary language spoken at home. Approximately, 24.21% of our students are English learners, 91.86% of our students qualify for free and reduced priced meals, and 11.58% of our students are students with disabilities. These factors make the school's job of creating an educational program that is centered around the specific needs of the community and filled with experiences and rich educational programming built to ensure student success.

At Bright Star Schools, we are guided by our core values and our highest ideals for our students, staff, and schools. The following are Bright Star Schools' Mission, Vision and Core Values.

Vision: Bright Star students will become leaders who act with integrity and champion equity to enrich our communities and the world.

Mission: At Bright Star Schools, our mission is to provide holistic, inclusive support for all students to achieve academic excellence and grow their unique talents so that they find joy and fulfillment in higher education, career, and life.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

As we reflect on our annual performance, Bright Star Schools remains committed to evaluating our progress using data from the California School Dashboard and local assessments. Over the past year, we have celebrated notable achievements and acknowledge ongoing challenges and remain dedicated to refining our strategies to ensure equitable opportunities for all students. Based on the 2025 CA School Dashboard, our strengths and growth areas are as follows:

- **Exceptional Mathematics Performance:** Mathematics performance demonstrated significant growth, with All Students improving 24.5 points to 17.0 points above standard, earning a Blue performance level. All reportable student groups also achieved Blue performance levels, reflecting strong and consistent outcomes across the school. This includes English Learners at 18.1 points above standard (Blue), increasing 20.0 points; Hispanic students at 21.7 points above standard (Blue), increasing 18.5 points; and Socioeconomically Disadvantaged students at 19.1 points above standard (Blue), increasing 29.6 points. These results reflect substantial growth across all student groups and indicate that students are exceeding grade-level standards in mathematics.
- **Zero Suspensions:** Our Suspension Rate held at 0.0% (Blue), with all five reportable student groups earning Blue. We are proud that our positive behavioral supports create a nurturing learning environment.
- **Strong ELA Improvement:** English Language Arts performance showed significant improvement as well, with All Students increasing 34.3 points to 17.2 points below standard, earning a Yellow performance level. All reportable student groups also received Yellow performance levels, demonstrating consistent growth across groups. This includes English Learners at 15.1 points below standard (Yellow), increasing 30.6 points; Hispanic students at 12.8 points below standard (Yellow), increasing 36.0 points; and Socioeconomically Disadvantaged students at 17.3 points below standard (Yellow), increasing 35.4 points. These gains across all student groups reflect strong upward momentum in literacy and indicate that the school is continuing to move closer toward proficiency.

We are very encouraged by the significant growth we've seen over the past year, as shown by our performance on the CA School Dashboard, however, we acknowledge the challenges we still face and the current opportunities for growth.

- Opportunity to Strengthen English Learner Progress: 43.2% of our English Learners made progress (Orange), while this is close to the state's rate of 46.4% , still shows a decline of 7.8 percentage points. We are committed to renewing our focus on designated ELD instruction and progress monitoring.
- Student Group Attendance: While our overall chronic absenteeism declined to 19.0% (Yellow), our Students with Disabilities received Red (35.3% chronically absent) and African Americans received Orange (20.8% chronically absent). We are committed to developing targeted attendance strategies for these student groups.

In response to elevated chronic absenteeism, particularly among students with disabilities and Black students, the school has strengthened its Multi-Tiered System of Supports (MTSS) for attendance. A cross-functional team meets regularly to analyze attendance data, identify students at risk, and implement targeted interventions. This has included the launch of the Care Cub Club, an early-intervention mentoring strategy that pairs students with consistent staff mentors for daily check-ins and family outreach, resulting in improved attendance for over half of participating students. In addition, the school has implemented schoolwide attendance incentives, including recognition programs and end-of-year rewards for strong attendance. These combined targeted and universal strategies have contributed to a measurable increase in average daily attendance compared to the prior year, while prioritizing support for student groups most impacted by absenteeism.

Additionally, in response to our decline in English Learner Progress, the school refined its Designated English Language Development (ELD) instructional block to provide more differentiated and targeted support aligned to students' Summative ELPAC proficiency levels. Instruction is now more intentionally tailored to students' needs across listening, speaking, reading, and writing domains, strengthening access to language development within core instruction. In addition, the school implemented ELPAC Interim Assessments for all English Learners, providing ongoing, actionable data to monitor progress and adjust instruction throughout the year. These enhancements have strengthened data-driven instructional practices and increased the school's ability to provide timely, targeted supports, positioning English Learners for improved language acquisition and overall academic success.

Bright Star Schools values the ongoing engagement of educational partners as an essential component of the Local Control and Accountability Plan (LCAP) development process. Throughout the year, the school gathered input from students, families, staff, school leaders, and community partners through surveys, meetings, data reviews, family conferences, and educational partner engagement sessions. Feedback from educational partners, combined with analysis of student achievement, school climate, attendance, and college and career readiness data, directly informed our planning for 2026-2027. Overall feedback from educational partners was positive, as reflected in stakeholder survey results that highlighted strong satisfaction with school culture, academic supports, communication, and student learning experiences.

The following updates reflect priorities and recommendations identified through this collaborative engagement process.

Goal 1:

We will implement refinements to specific actions to strengthen instructional practice. These include the continuation of a professional development series with an external partner focused on Math and aligning ELD and Math standards, ongoing coaching through a literacy specialist model (adjusted from two positions to one), and the adoption of a new curriculum supported by vendor-led training for site leadership. The principal and assistant principal will participate in these trainings and provide ongoing coaching to teachers to ensure strong curriculum fidelity.

Metric 1.3, ELA DFS Update: 3-year targets were met for most student groups in year 2 for this metric, so new 3-year targets have been set to account for the year 2 achievements.

Metric 1.4, Math DFS Update: 3-year targets were met for most student groups in year 2 for this metric, so new 3-year targets have been set to account for the year 2 achievements.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, all actions identified under Goal 1 were carried out as intended, with full implementation across each area and no substantive differences between planned and actual execution. The school maintained coherence between its strategic priorities and instructional practices, ensuring that key systems and supports were consistently delivered to students.

Staffing structures remained stable and aligned to program goals. General education classrooms were staffed with appropriately credentialed teachers, supporting consistent core instruction across grade levels. Services for students with disabilities were implemented as designed, including access to inclusive education teachers, school psychologists, and required direct services. English Learner supports were also delivered as planned, with designated personnel and aligned curriculum supporting language acquisition and access to grade-level content.

Instructional programs continued to be supported through the use of adopted curriculum and the provision of necessary materials and supplies. Classrooms were equipped with standards-aligned resources, allowing teachers to effectively implement lessons and provide differentiated learning experiences. Academic software and digital tools were also utilized to support instruction, assessment, and progress monitoring.

Intervention systems were implemented to provide additional support for students requiring targeted assistance. Site-based staff coordinated intervention services, with a focus on English Learners and students with disabilities, ensuring alignment between identified student needs and instructional supports. These efforts were reinforced through regular data review and the use of assessment tools to inform instructional adjustments.

Ongoing professional learning and instructional support structures were also maintained throughout the year. Teachers engaged in professional development opportunities, and instructional leadership roles, including grade level leads, content leads, and support staff, played an active role in strengthening classroom instruction and supporting student learning. These efforts contributed to a more cohesive instructional program and increased support for unduplicated student group

A key success in implementation was the strategic investment in literacy, including the hiring of two additional literacy specialists, which strengthened early literacy instruction and intervention systems across the school. This additional capacity allowed for more targeted support

for students performing below standard, particularly in English Language Arts, and supported progress toward improving outcomes for historically underserved student groups.

While overall implementation was strong, one challenge encountered during the year was the effort to more seamlessly integrate academic initiatives into the after-school program. Due to staffing constraints, the school was not able to fully realize this vision of expanded integration during the 2025–26 school year. Despite this challenge, core instructional and intervention programs during the regular school day remained fully implemented, ensuring that students continued to receive the intended academic supports.

In summary, the consistent implementation of all Goal 1 actions established a strong operational foundation during the 2025–26 school year. This level of fidelity supports continued efforts to refine instructional practices and improve outcomes for all students.

The actions outlined in Goal 1 have been largely effective in supporting progress toward increased academic achievement in English Language Arts, Mathematics, and English Learner proficiency. Through the consistent implementation of standards-aligned curriculum, targeted intervention structures, English Learner supports, and ongoing professional development, the school has demonstrated measurable gains in key academic indicators, particularly in ELA and Mathematics.

In English Language Arts, the school demonstrated significant improvement, with All Students increasing 34.3 points to 17.2 points below standard, maintaining a Yellow performance level. This substantial growth reflects the effectiveness of strengthened literacy systems, including the addition of dedicated Literacy Specialists who provide targeted small-group intervention and ongoing professional development to calibrate instructional practices across grade levels. These efforts have focused on foundational literacy, reading comprehension, and writing, resulting in improved instructional coherence. The expansion of high-dosage after-school tutoring, including early literacy intervention for Kindergarten students based on DIBELS and i-Ready data, further contributed to these gains. Despite this progress, performance remains below the state average (8.1 points below standard), indicating that while the actions have been effective in accelerating growth, continued focus is needed to close the remaining gap.

In Mathematics, the actions under Goal 1 have been highly effective, resulting in All Students increasing 24.5 points to 17.0 points above standard and earning a Blue performance level. This high level of performance extended across all numerically significant student groups, each achieving Blue, reflecting both strong outcomes and equitable performance. The success in Mathematics is attributed to several key implementation strategies, including a semi-departmentalized instructional model that allows for teacher specialization, the use of a rigorous standards-aligned curriculum, and strong staff retention, which has supported instructional consistency over time. Additionally, intentional collaboration structures, such as vertical alignment with the network math director and increased teacher collaboration time, have

strengthened instructional quality and coherence. These combined efforts have led to sustained growth and positioned the school among the highest-performing in its local context. As a result, the school has met and exceeded its three-year target in Mathematics, demonstrating a high level of effectiveness in the implementation of Goal 1 actions.

In English Learner Progress, the effectiveness of actions has been more mixed. The English Learner Progress Indicator declined by 7.8 percentage points to 43.2% of students making progress, resulting in an Orange performance level, and remains below the state average of 46.4%. This decline indicates that, while systems and supports were implemented, they have not yet resulted in improved outcomes. In response, we have taken meaningful steps to strengthen implementation, including refining the Designated ELD instructional block to ensure more differentiated and targeted instruction aligned to students' Summative ELPAC proficiency levels. Instruction is now more intentionally aligned to students' language domains, allowing for more precise support in listening, speaking, reading, and writing. Additionally, the implementation of ELPAC Interim Assessments for all English Learners has introduced a stronger data-driven approach, enabling teachers to monitor progress throughout the year and adjust instruction accordingly. While these enhancements represent important improvements in practice, their full impact on student outcomes is still emerging, and continued focus for SY 26-27 will support our efforts to ensure these systems translate into measurable gains in English Learner proficiency.

Overall, the actions associated with Goal 1 have been effective in driving strong academic growth in ELA and Mathematics, including meeting established multi-year targets, while English Learner Progress remains an area for continued refinement and focused implementation.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflection on current year implementation and engagement with our educational partners, we will largely continue with the current strategies outlined in Goal 1. We are encouraged by the progress we have seen and believe that maintaining consistency in our approach will support continued growth toward our three-year targets in academic achievement for all students.

While maintaining the overall structure of our goals, metrics, and actions, we are making a few intentional updates to select metrics and action steps to respond to partner feedback and enhance our ability to monitor progress and impact, we are making the following updates to Goal 1:

- Metric 1.3, ELA DFS: 3-year targets were met for most student groups in year 2 for this metric, so new 3-year targets have been set to account for the year 2 achievements.
- Metric 1.4, Math DFS: 3-year targets were met for most student groups in year 2 for this metric, so new 3-year targets have been set to account for the year 2 achievements.

Additionally, Stella Elementary Charter Academy will implement refinements to specific actions to strengthen instructional practice. These include the continuation of a professional development series with an external partner focused on Math, ongoing coaching through a literacy specialist model (adjusted from two positions to one), and the adoption of a new curriculum supported by vendor-led training for site leadership. The principal and assistant principal will participate in these trainings and provide ongoing coaching to teachers to ensure strong curriculum fidelity.

These adjustments reflect a commitment to continuous improvement while maintaining alignment to the existing LCAP framework.

Goal Analysis [2025-26]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2025–26 school year, all actions identified under Goal 2 were implemented as planned, with no substantive differences between the intended design and actual execution. The school maintained a consistent focus on fostering a positive, engaging, and supportive school culture while strengthening family engagement systems to ensure all students, particularly those in unduplicated student groups, had access to the social-emotional and community-based supports necessary for success.

Enrichment programming was implemented as intended, providing students with access to expanded learning opportunities beyond the core academic program. These included afterschool programming, Life Experience Lessons such as overnight field trips, and wellness-focused opportunities for both students and families. These experiences were designed to broaden student exposure to cultural and real-world learning opportunities and were particularly impactful for our significant student groups.

Student and family support structures were fully implemented through the coordination of counseling services, restorative practices, and student culture systems. School counseling staff, Deans of Student Affairs/Culture, and office support personnel worked collaboratively to provide students with consistent access to trusted adults who could support both academic and social-emotional needs. In alignment with Learning Recovery Emergency Block Grant (LREBG) priorities, the school also expanded its capacity to support student wellness and mental health through increased counseling services and related supports. These efforts were aligned to identified needs in school climate data, including suspension and attendance trends, and were supported by ongoing monitoring of key metrics such as suspension rates, chronic absenteeism, and student survey data.

Technology systems supporting school culture were also implemented as planned, including platforms used to monitor attendance, behavior, and social-emotional data. These tools enabled staff to track trends, respond proactively to student needs, and support a more data-informed approach to school climate and engagement.

Student activities and school-wide events were carried out as intended, contributing to a positive and inclusive school environment. These activities provided opportunities for student recognition, celebration, and community-building, reinforcing a strong sense of belonging among students.

Family engagement systems were implemented with some adjustments during the 2025–26 school year. Due to staffing and budget constraints, the school no longer maintained a dedicated Family Engagement Coordinator at the site level, and network-level support was reduced as the role expanded to serve multiple schools. While the network-level support was more limited this school year, many of the responsibilities previously held by our Family Engagement Coordinator were taken on by other personnel on site. As a result, the school continues to face challenges with tracking attendance accurately for all events. We also reduced the number of planned family engagement events by one and streamlined outreach efforts. Communication with families continued through established platforms such as ParentSquare, and staff supported engagement efforts as feasible, ensuring that families remained informed and connected to the school community despite the reduction in dedicated resources.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

No material differences between budgeted and estimated actuals.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The actions implemented under Goal 2 have been highly effective in fostering a positive, safe, and engaging school culture, with strong outcomes in behavior, attendance, and family engagement. Through enrichment programming, targeted student support services, and intentional family engagement systems, the school continues to build a supportive and inclusive environment for students and families.

In terms of student engagement and culture, the school demonstrated strong outcomes in behavior and improving attendance trends, while maintaining a 0% expulsion rate:

Attendance Rate: 93.85% (increase from 91.32%)

Suspension Rate: 0.0% and Blue on the CA Dashboard (maintained from prior year)

Chronic Absenteeism: 19.0% (Yellow, declined from 20.1% and 31.2% in prior years)

88% of students who feel safe at school

80% of students who feel like they belong at school

These outcomes reflect the strong effectiveness of Action 1 (Enrichment Programming) and Action 2 (Student and Family Services Personnel) in building a culture centered on connection, belonging, and proactive support. Programs such as Life Experience Lessons and schoolwide enrichment opportunities increased student engagement, while expanded counseling services including access to a family and marriage counselor trainee, strengthened the school's ability to address social-emotional and behavioral needs through a comprehensive MTSS framework.

The school's restorative and proactive approach to behavior has been particularly impactful. Rather than relying on exclusionary discipline, staff consistently implemented restorative practices, parent meetings, behavior plans, and counseling supports, contributing to the sustained 0% suspension rate across all student groups. This work was reinforced through professional development aligned to a "warm demander" approach, balancing strong relationships with high expectations, and supported by organization-wide training on Tier 1 and Tier 2 culture systems and de-escalation strategies.

In addition, the launch of the Hearts of Empathy campaign further strengthened school culture by publicly recognizing acts of kindness and care, reinforcing positive peer interactions and a strong sense of community across campus.

The implementation of Action 3 (School Culture Software) supported a data-informed approach to student engagement, allowing staff to monitor trends in attendance, behavior, and student experience data. This data was actively used within an enhanced MTSS framework for attendance, where a cross-functional team met regularly to identify students at risk and assign targeted interventions. Through this work, initiatives such as the Care Cub Club mentoring program led to improved attendance outcomes for 17 of 32 identified students. Additionally, universal incentives such as attendance-based field trips and classroom competitions (LEADER Board) contributed to increased student motivation and engagement, with average daily attendance improving year over year.

While overall chronic absenteeism improved, the data highlights an opportunity for continued growth for specific student groups, particularly students with disabilities (35.3% chronic absenteeism, Red), indicating the need for continued targeted supports and differentiated strategies. The school has already taken proactive steps to address this through relationship-based interventions and increased communication with families, including monthly attendance updates.

Family engagement remains a significant strength and an area of high effectiveness under Actions 5–7. The school achieved:

Parent Rating: 98% of families rated the school positively

Parent Survey Participation: 100% response rate

Parent Education Attendance: 40.65% (increase from 11%)

Conference Attendance: 64.75%

Unduplicated Pupil Family Attendance at School Events: 55.78%

These outcomes reflect strong implementation of family engagement systems, including the role of the Family Engagement Coordinator (Action 5) and consistent communication through ParentSquare (Action 6), ensuring accessibility for multilingual families. Events such as Literacy Night, Math Night, Career Day, Multicultural Night, and performance showcases provided meaningful opportunities for families to engage in their child’s learning and strengthened school-to-home partnerships. The use of translation services and inclusive practices further ensured equitable access for all families.

While Back to School Night attendance declined (27.7%), overall engagement data and survey results indicate that families remain highly connected and satisfied with the school, suggesting that engagement efforts throughout the year are strong even as participation varies by event type.

In summary, the actions under Goal 2 have been highly effective in promoting a positive, engaging, and supportive school culture, with exceptional outcomes in behavior and strong family engagement systems. Continued focus on reducing chronic absenteeism for specific student groups and maintaining high levels of family participation will further strengthen these outcomes moving forward.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflection of Year 2 implementation, review of outcome data, and engagement with educational partners, the school will not be making any significant changes to Goal 2, including the overall goal, major actions, or intended areas of focus for the 2026–27 school year. Current actions and systems continue to demonstrate effectiveness in supporting student engagement, school culture, student safety, and family partnership, and the school remains committed to sustaining and refining these efforts as part of the final year of the current three-year LCAP cycle.

However, the school will make a strategic update to continue to support and uplift our family engagement efforts.

Updates for 2026–27 include:

- Expanded Community Schools efforts to increase both the frequency and authenticity of family engagement opportunities through the continued development of the Parent Ambassador Program and strengthened family collaboration structures.
- Increased focus on building additional community partnerships to expand enrichment opportunities and provide students and families with greater access to community-based programs and experiences.

Overall, the actions under Goal 3 were implemented as planned, with no substantive differences between the intended design and actual execution. The school maintained a consistent focus on ensuring that facilities remained safe and in good repair, operational systems functioned effectively, and students had access to properly credentialed staff and standards-aligned instruction.

Key operational systems were implemented with fidelity, including the provision of operational materials (Action 3.1) and software systems (Action 3.3) to support daily school functions. These resources ensured that staff had the necessary tools to effectively manage instruction, communication, and school operations. In addition, operational personnel and services (Action 3.2) were in place to maintain a safe and supportive learning environment, including custodial services, facilities maintenance, and oversight of school operations. Broader operational services (Action 3.4), such as legal, audit, and compliance-related supports, were also implemented as planned, contributing to overall organizational stability and accountability.

A key success of implementation was the school's ability to maintain safe, functional facilities and consistent operational systems, which supported uninterrupted instruction and a stable learning environment for students and staff. These systems ensured that classrooms remained conducive to learning and that staff were able to focus on delivering high-quality, standards-aligned instruction.

While implementation was strong overall, ongoing attention is required to maintain and continuously improve facilities, operational efficiency, and staffing stability to meet the evolving needs of the school community. Continued investment in these foundational systems will ensure that the school remains well-positioned to support student learning and staff effectiveness.

In summary, Goal 3 actions were fully implemented with fidelity, resulting in stable operations, safe facilities, and the infrastructure necessary to support high-quality instruction. These efforts provide a strong foundation for continued success in delivering standards-aligned educational programs for all students.

The actions implemented under Goal 3 have been effective in maintaining safe, functional, and well-maintained school environments while ensuring students continue to receive standards-aligned instruction from appropriately credentialed staff. Through operational services, facilities maintenance, staffing supports, and technology systems, the school has maintained strong systems that support both daily operations and student learning.

During the 2025–26 school year, all monitored Bright Star schools were found to have sufficient standards-aligned instructional materials available for all students through the Williams monitoring process. Facilities and Safety Inspection scores ranged from 94.53% to 100%, reflecting ratings of Good to Exemplary. This reflects the effectiveness of Actions 1-4, including operational materials, facilities personnel and services, software systems, and contracted operational supports. These actions ensured that school facilities remained clean, safe, and conducive to learning throughout the school year. Custodial services, maintenance supports, operational supplies, and ongoing compliance monitoring contributed to maintaining a positive and secure learning environment for students and staff.

Operational and technology systems also continued to effectively support school functionality and organizational efficiency. Through Action 3 (Software – Operations), staff maintained access to operational platforms and cloud-based systems that support communication, compliance, instructional access, and daily school operations. In addition, operational services provided under Action 4 (Operational Services) ensured continuity in critical functions such as payroll processing, legal and audit compliance, facilities consulting, insurance coverage, and district oversight requirements.

In terms of instructional quality, the school maintained strong implementation of standards-aligned instructional materials and curriculum. 100% of instructional materials were verified as aligned to California State Standards, and 100% of students had access to standards-aligned instructional materials both at school and at home. English Learners also continued to receive instruction aligned to both CCSS and ELD standards, supported through ongoing professional development, curriculum vetting, and instructional coaching structures.

Credentialing and staffing stability also remained areas of effectiveness. According to the most recent SARC data, the school had 1 teacher identified as ineffective under ESSA, and 0 teachers assigned out-of-field. Staffing and credentialing are monitored regularly to ensure compliance and to support students with appropriately credentialed teachers in all classrooms.

The school also continued to prioritize staff well-being and organizational alignment. Based on staff survey results, 100% of staff reported feeling their workplace is safe, while 93% indicated they understand how their role contributes to the broader mission and vision of the organization. These results reflect continued efforts to foster a positive work environment, maintain strong operational systems, and support staff collaboration and effectiveness.

Overall, the actions under Goal 3 have been effective in supporting safe school facilities, operational stability, credentialed staffing, and access to standards-aligned instruction. Continued implementation of these actions will help ensure students and staff continue to learn and work in environments that are safe, supportive, and aligned to high expectations for teaching and learning.
