**Bright Star Schools Board of Directors
Minutes of the Special Meeting**

A meeting of the Board of Directors of Bright Star Schools was held on **Friday, June 6, 2025** at Stella Elementary Charter Academy and via teleconference, pursuant to notice duly given.
